

Mix 94.9's Gettin' Piggy With It

CONTEST RULES

1. **Dates/Eligibility.** NO PURCHASE NECESSARY TO ENTER OR WIN THE CONTEST. A purchase will not improve chances of winning and is not necessary to participate and/or win. Mix 94.9's Gettin' Piggy With It (the "Contest") sponsored by WREW Mix 94.9 (the "Station") begins at 9:00 am Eastern Time ("ET") on September 13, 2021 and continues until further notice ("Contest Period"). Station may change the dates and/or terms of the Contest without prior notice. Any material changes will be broadcast on the Station and posted on the 949Cincinnati.com website (www.949cincinnati.com). The Contest is open to U.S. residents residing in Ohio, Kentucky, or Indiana, 18 years of age and older with a valid driver's license or valid photo ID. Employees or agents of Station, Hubbard Radio Cincinnati LLC, Cincinnati or Dayton area radio stations, advertising agencies or sponsors related to the Contest, or any other entity associated with the Contest, as well as members of the same household of any such employee or agent may not participate.

2. **How to Enter.** Each weekday during the Contest Period, Station will solicit for caller nine (the "Contestant") every hour starting at 9:00am Cincinnati time (the "Play"). The final Play each day will occur at 5:00pm Cincinnati time. The designated phone number to call is 513-749-5309. Only caller nine will be able to make one guess as to the cash amount (the "Jackpot") to the exact cent that is currently in Hank The Piggy Bank.

If Contestant correctly guesses the Jackpot, that Contestant will be deemed a winner and will win the current prize amount.

If, however, Contestant does not correctly guess the Jackpot, Contestant is not a winner and there will be no winner for that play. The DJ will announce on-air if the guess made by the Contestant is too high or too low to the Jackpot.

Guesses will only be accepted via the telephone. No other form of entry submission will be accepted.

All contest entries will become the property of Hubbard Radio Cincinnati LLC and will not be acknowledged or returned.

3. **Prize.** The starting jackpot for this Contest is \$100 ("Jackpot"); the minimum Jackpot available to be won is \$100. Total number of prizes will vary based upon the number of individual jackpots awarded.

Prize cannot be transferred, assigned, or substituted. All taxes are solely the responsibility of winner. Prize may be redeemed only by the official prize-winner. Station may substitute a prize of equal or greater value for any prize that becomes unavailable for any reason. The name of the winner may be used for publicity purposes, and may also be entered into subsequent contests held by Station, Hubbard Radio Cincinnati LLC and the station's promotional database.

4. **Conditions and Restrictions.** Limit one (1) winner per household during the Contest period.
